LOCATION

Crediton is a busy market town 7 miles to the West of Exeter with a mix of national and local retailers along its popular High Street.

The property is located on the corner of High Street and Searle Street, adjacent to the Crediton Museum and close to Tesco Express and the Weatherspoon's Public House, The General Sir Redvers Buller.

DESCRIPTION

The property, which is Grade II listed, is suitable for a variety of uses subject to planning and is currently fully fitted as a restaurant, previously trading as the Indian Lounge.

The ground floor provides seating for 26 covers and an electric serving hoist giving access to the first floor kitchen and the basement store. There is a single WC with granite tiling.

The first floor provides additional seating for 22 covers and has a kitchen with gas range, double sink, various food warmers and three fridge freezers.

The basement comprises a lobby area giving access to the granite tiled WCs and a storage area.
